## Executive Summary

The Florida Disaster Resilience Initiative consists of 5 phases:

- 1: Elevating the Voices of Vulnerable Communities
- 2: Collaborative Systems for Preparedness & Response
- 3: Resolving Mission Critical Gaps
- 4: Establishing Communities of Opportunity with Social Equity
- **5**: Building a Blue-Green Political Economy for Regeneration

This report details work undertaken in Central Florida in 2019 as part of Phase I. This phase included training for Community Captains, community forums, and surveys conducted within each participating community. This report, and the accompanying online community presence in the <u>South Florida Resilience System</u> comprise the documentation of these efforts.

Information included in this Community Report was gathered using the following methods:

- Formal and informal interviews with Organization Leads located in or serving the community;
- Community Forums where:
  - Gaps and proposed solutions were discussed and recorded, and
  - Assets, hot spots (areas of concerns), and proposed resilience hubs were discussed and mapped.
- 30 Household *Mission Critical Function Surveys*: These surveys are designed to determine if the community is tending toward resilience or vulnerability. Survey respondents rated twenty six critical functions on the following scale:



• 30 Household *Housing and Emergency Services Surveys:* Residents described their residence type, any damage to their home as a result of Hurricane Irma, the time taken to repair the damage, and funding sources for the repairs. This survey



also documented where residents received information during and after Hurricane Irma, and their level of knowledge about disaster preparedness.

• Household *Skills and Equipment Inventory Surveys were completed.* These listed residents who have volunteered their services, skills, or property to be used in the community to assist their neighbors in the event of a disaster.

#### Community Leadership

Ms. Crystal Johnson, President of Community Forum Foundation, Inc. served as Community Captain for Dunbar. As such, she was responsible for holding and documenting a Community Forum, and for the completion and submission of community surveys.

A larger initiative to serve the community with a Resilience Hub and distribution to the community is being led by Crystal Johnson together with both lay leaders and Pastor Velma Black-Smith, associated with The Apostolic Church of God.



## Findings

The 30 Household *Mission Critical Function Surveys* determined that the top priority gaps in Dunbar were:

- Renewable vs Grid Energy
- Climate Threat Mitigation & Transformation
- Energy Lighting & Cooking
- Agriculture Production Scale
- Psychosocial Resilience

In addition to the 23.3% of respondents that experienced electrical power outage (many for as much as 2 weeks), the top 3 types of damage after Hurricane Irma reported by 30 respondents to the Household *Housing and Emergency Services Surveys* were:

- Roof damage (26.7%)
- Water damage (20.0%)
- Tarps on Roofs (13.3%)

Heating system damage, window damage, sewage/septic damage, and electrical power damage were all repaired in less than 6 months. Electrical power was off for two weeks in some locations. All respondents with tree damage reported that repairs took longer than 6 months. Both the minor roof damage and the tarps on roofs required more than 6 months to repair in two thirds of homes reporting such damage. Half of the households reporting cooling system damage required more than 6 months to complete repairs, and a quarter of households reporting water damage required more than 6 months to affect repairs.

A quarter of responding households applied for funding to affect repairs. Half of those funded their repairs with FEMA funds and a fifth of them funded repairs with home insurance. Renters Insurance, Rebuild Florida and unspecified "Other Funding" sources were funded the remaining reported repairs.

There is a strong need for notification about when and how to evacuate, how to obtain supplies prior to a storm. Residents reported that as Hurricane Irma approached, they did not know where an emergency shelter was or how they would get there. Community Leaders stated that there were no emergency shelters open in the city that they were aware of, and that expected emergency shelters were flooded.

There is also a need to educate about preparedness. Less than a third of respondents could answer questions about preparedness, including how to comply with a boil water order, how much water is needed to shelter in place, and where to obtain sandbags. Less than a fifth of respondents knew how to get to an emergency shelter, how to find their emergency radio stations, or where an emergency shelter was.

Lack of climate threat mitigation, and infrastructure failures that resulted in flooding and the lengthy loss of power after Hurricane Irma, convinced local leaders at The Community Forum Foundation, Inc. to train a Youth Resilience Corps and to pursue the development of a Resilience Hub. The first Youth Resilience Corps training took place over Spring Break 2019. An EMS officer taught how to volunteer at a FEMA Point of Distribution, and the fire department taught first aid. Youth also worked on their family preparedness plans, and learned about the public health effects of climate change. Additional training is planed for Fall 2019.

Lack of communications and lack of electrical power in Dunbar after Hurricane Irma created hardship within the community, particularly for the elderly and those with medical needs. As a result, residents who participated in the surveys and the community forum expressed a desire for renewable energy, with a preference for solar power at a Resilience Hub that could serve the community. Pastor Thelma Black-Smith at Apostolic Church of God is willing to accomodate a storage structure on church property to hold preparedness supplies.

The existence of an arsenic sludge dump and multiple Brownfield sites in the community have residents concerned about the effects of flooding and high winds on the potential spread of contaminants. The need for education about the contamination as well as remediation at the affected sites, was identified in discussions with community leaders. The current Florida Department of Environmental Protection Contamination Locator Map<sup>1</sup> for Dunbar identifies four (4) Brownfield Sites in Zip Code 33916, which includes the Homearama arsenic sludge dump on South Street. Zip Code 33916 also has 7 Active Petroleum Cleanup sites, 10 Pending Petroleum Cleanup Sites, 5 Active Other Waste Cleanup Sites, and 2 pending "Other" Waste Cleanup Sites.

## **Community Description**

## Location

Dunbar is in Ft. Myers, Florida. It is a neighborhood in the Cape Coral Area in Lee County. Almost all of the surveys (58 of 60) were completed within Zip Codes  $33916^2$  and  $33901^3$ . These were in Census Tracts 000502, 000600, 001201, and 001000. One survey was completed in Cape Coral Zip Code  $33914^4$  in Census Tract 010410. Another one was completed in Lehigh Acres Zip Code  $33972^5$  in Census Tract 040210.




Table 1. Geography of Census Block Groups Surveyed



## School and Legislative Districts

All Zip Codes surveyed are served by the Lee County Unified School District Zip Code <u>33916</u>, <u>33901</u> and <u>33914</u> are in Congressional District FL-19 and State Senate District FL-27. Zip Codes <u>33916</u> and <u>33901</u> are in State House District FL-78, and Zip Code <u>33914</u> is in State House Districts FL-76 and FL-77. Lehigh Acre's Zip



Code <u>33972</u> is served by Congressional Districts FL-17 and FL-19, State Senate District FL-28, and State House District FL-79. Lee County Joint Unified Local Mitigation Strategy 2017 Identified Risks

The four highest priority hazards identified in the Lee County Local Mitigation Strategy were Tornadoes, Thunderstorms, Flooding, and Hurricane Wind Damage. Each of these was labeled a Composite Hazard Index high priority.

## Dunbar and Vicinity Demographics

The 5 Census Block Groups in Dunbar (120710005023, 120710006001, 120710006002, 120710006003 and 120710012011) have between 69% and 100% minority populations (Table 3). The 100% minority population is in the area between Lincoln Blvd to the North and Canal St to the South; and between Highland Ave to the East and Ford St to the West. This area has a 76% low income population. The Census Block Group with a 97% low income population is located between Michigan Ave to the North and Lincoln Blvd to the South; and between Palmetto Ave to the East and Henderson Ave to the West. The hightest percentage low income population is in the two Dunbar Census Block Groups 120710005023 (Michigan Ave to the North, Lincoln Blvd to the South, Palmetto Ave to the East, and Henderson Ave to the West) and 120710006001 (Larmie St and Edison Ave to the North, Canal St to the South, Palm Ave and Ford St to the East, and Evans Ave and the Railroad track to the West). The area with the highest percentage of the population under age 5 is in Fort Myers Census Block Group 120710012011, located between Canal St to the North and Colonial Blvd to the South; and between Veronica Shoemaker Blvd to the East and Palm Ave to the West. The Cape Coral Census Block Group 120710402101 has a 41% minority population. The highest percentages of elderly are 21% and 20% in Dunbar Census Block Groups 105001 and 189004.<sup>7</sup>

## Dunbar and Vicinity Environmental Health Concerns

Table 4 summarizes elevated environmental indicators by percentile in the US, meaning how the levels of contamination in these Census Block Groups compare to the contamination in all other Census Block Groups in the US. Higher percentiles mean that the Census Block Group in the table has higher concentrations of the contaminant in guestion than other Census Block Groups in the US. Proximity to facilities with Required Risk Management Plans is elevated in the Dunbar Census Block Groups shaded in blue in Table 4 (81st to 96th percentile) and the nearby Ft. Myers Census Block Group 120710002). Wastewater Discharge Indicators are also elevated in the Census Block Groups in Dunbar shaded blue in Table 4 (88th to 98th percentile). In addition there are many homes constructed prior to the 1960's, which appears in the table below as the lead paint indicator.<sup>8</sup> Note that homes of this age are particularly vulnerable to wind damage, as they were constructed prior to changes in Florida's building code that were designed to make homes better able to withstand hurricanes. In Dunbar Census Block Groups 120710006002 and 120710005023 are in the 51st and 54th percentile respectively. The nearby Ft. Myers Census Block Group 120710010002, the Lead Paint Indicator is in the 62nd percentile.

## Contaminated Sites

The current Florida Department of Environmental Protection Contamination Locator Map<sup>9</sup> for Dunbar identifies four (4) Brownfield Sites in Zip Code 33916, which includes the Homearama arsenic sludge dump on South Street. Zip Code 33916 also has 7 Active Petroleum Cleanup sites, 10 Pending Petroleum Cleanup Sites, 5 Active Other Waste Cleanup Sites, and 2 pending "Other" Waste Cleanup Sites. In addition, there are 10 Active Petroleum Cleanup sites, 28 Pending Petroleum Cleanup Sites, and 2 Active Other Waste Cleanup Sites in Zip Code 33901. The "Other Waste Cleanup Site" category includes:

<u>Dry Cleaning</u>: Sites contaminated with dry cleaning solvents that are eligible to be cleaned up by the DEP

<u>Responsible Party</u>: Sites that will be cleaned up by the party responsible for the contamination or by a party that did not cause the contamination but has accepted responsibility for cleanup

<u>State Funded</u>: Sites that will be cleaned up by the DEP because there is no party identified that is responsible for the contamination or able to clean it up

<u>State-Owned Lands Cleanup</u>: Sites on state properties (such as state parks or state-owned buildings) that will be cleaned up by the DEP

<u>Hazardous Waste</u>: Sites at regulated hazardous waste facilities that will be cleaned up by the facility owner or operator in accordance with the federal hazardous waste program.


Map 1. Contamination Locator Map<sup>11</sup>




## Map 2. Mission Critical Functions: Household Vulnerability Scores of Respondents in Dunbar and Vicinity

Note that the average Vulnerability Score, indicated by point color, across the 26 domains was between 1 and 6





The categories with the lowest average rating are considered to be the most vulnerable functions. Renewable versus Grid Energy received the lowest ranking, followed by Climate Threat & Mitigation, Energy for Lighting & Cooking, and Agricultural Production Scale. Community Commons Availability ranked the highest, and therefore regarded to be the most sustainable.




#### Graph 1. Average Mission Critical Function Ratings for Each Function



Housing and Emergency Shelter Surveys required residents to describe damage to their home as a result of Hurricane Irma, time taken to repair the damage, and funding sources for the repairs. This survey also assessed where residents received information during and after Hurricane Irma, and their level of knowledge on disaster preparedness.

*Type of damage to homes after Hurricane Irma*: Of the 30 respondents to the Housing and Emergency Shelter Survey, 26.7% reported roof damage, with 13.3% reporting that they had a tarp placed on their roof. Electrical power failure was reported by 23.3%, and Water damage was reported by 20.02% of respondents. Additional damage reported included: tree damage (6.7%), cooling system damage (6.7%), heating system damage (3.3%), sewage/septic damage (3.3%), and window damage (3.3%), and unspecified "Other" damage (10.0%).


Graph 2. Housing and Emergency Shelter Survey Results

*Time to complete repairs after Hurricane Irma*: The repairs that were all completed in less than 6 months included: heating system damage, window damage, sewage/septic damage, and electrical power outage. All respondents with tree damage reported that repairs took longer than 6 months. Both the roof damage and the tarps on roofs required more than 6 months to repair in 66.7% of homes reporting such damage. Half of the households reporting cooling system damage (50.0%) required more than 6 months to affect repairs. A quarter (25.0%) of households reporting water damage required more than 6 months to affect repairs.

Dunbar & Vicinity: Time to Repair Damage after Hurricane Irma





*Funding Repairs*: Of the 26.7% of respondents that applied for funding, half (50.0%) funded repairs with FEMA funds, 20.0% applied for home insurance. Renters Insurance, Rebuild Florida and unspecified "Other Funding" sources were each used by 10.0% of those seeking funding. The graph below displays the distribution of funding sources for the repairs.



*Preparedness Resources:* Respondents were asked questions that assessed the information and physical resources they were able to obtain as the hurricane was approaching. Only 20% of respondents reported that they had sufficient information to make appropriate decisions about whether they would shelter in place or evacuate, and only 26.67% reported having sufficient information regarding how to evacuate. Only 36.67% were able to obtain the supplies they needed to shelter in place. Only 16.67% of respondents knew where the nearest emergency shelter was and how to get there.




#### **Graph 5. Preparedness Resources**

*Preparedness Knowledge.* Respondents were asked questions about preparedness. One third (33.33%) of respondents knew how to comply with a boil water order. Slightly over a quarter (26.67%) knew how much water needed to shelter in place, and 23.33% of respondents knew where to obtain sandbags. One fifth of respondents (20.00% knew how to get to an emergency shelter. One sixth of respondents (16.67%) knew how to find their emergency radio stations, and likewise one-sixth knew where their emergency shelter was. One tenth (10.00%) of respondents knew their evacuation zone, and only 3.33% knew the supplies pet owners must take with them and their pet to an emergency shelter.
